With firm determination we are to inform you that, on the 15th of January of the year 2022, the First Parliament in self-determination with direct democracy in self-candidacy was created and made effective. Considering that the Venetian National Assembly A.N.V, on 12/04/2021, appointed the Prime Minister (Moravio Pianegonda), the Ministers of the National Council and the Ministries of the Veneto People, in compliance with international guidelines, in particular of the New York Pacts, which in the first part of article 1, reads in the original English language:

All peoples have the right of self-determination. By virtue of that right they freely determine their political status and freely pursue their economic, social and cultural development.

By legislation of treaties, resolutions and international laws, having adopted the Swiss Constitution on a transitional basis, the following laws have been voted and approved by Parliament:

- A) On Monetary Policy (with reference to art. 99 of the Constitution);
- B) On the tax system (with reference to articles 127 ~ 135 of the Constitution);
- C) Membership of the International Chamber of Commerce ICC and consequently of the WCF World Chambers Federation (World Federation of Chambers of Commerce).

In addition, the following key points of the Veneto People for the liberation of the territories were voted and approved:

point 1 <u>Name</u>: **STATE OF THE VENETO PEOPLE** (it will then be the PEOPLE to decide by vote what the State of their Nation will be called ..!);

point 2 Boundaries: those claimed and defined in the Italian Legislative Decree N °212 of 13 December 2010;

point 3 Flag of the Nation and State of the Veneto People: GONFALONE DI SAN MARCO;

point 4 National Anthem of the State of the Veneto People: - JUDITHA TRIUMPHANS by the Composer, Antonio Vivaldi - Venetian National Anthem

point 5 <u>National Language</u>: the **VENETIAN LANGUAGE** has been recognized by **UNESCO** with the **ISO 639-3** "**vec**" identifier since 23/12/2013 and classified among the living languages in the **ETHNOLOGUE catalog**, as well as recognized by the Council of Europe in 1981, plus other local languages;

point 6 <u>Parliament's approval</u> of the adoption by the Government (National Council of the Veneto People) of the **SWISS CONSTITUTION** in full (in toto), as a constitutional model of the Veneto People;

point 7 National and International Festival of the Veneto People: its recurrence is set for 25th of APRIL;

point 8 Approved by law: **VENICE**, capital of the State of the Veneto People.

We ask for a meeting with the UN delegation, responsible for carrying out all the necessary procedures in order to obtain the liberation of the Venetian territories and independence, as required by international law and we reserve the right to keep you informed on the continuation of the most important steps in the future.

This is an official communication approved by the Parliament of the Veneto People.
