artistic, historical and cultural heritage of the millenary Venetian civilization. The Council of Ministers promotes the development of culture and scientific and technical research. Protects the landscape and the artistic heritage of the Venetian nation. The Council of Ministers solemnly adopts the principles of the World Code of Ethics for Tourism. (Attachment 1)

Law Decree n.26 of 2022.06.27.

The Government of the Veneto State,

aware of the duty to pave the way for the reconstitution of the Venetian nation, in the Venetian land which is mother, life, memory and history, the sacred place of our ancestors, the future for our children.

Considered,

the International Convention on Civil and Political Rights of the International Covenant on Civil and Political Rights and of the International Covenant on Economic, Social and Cultural Rights, adopted in 1966 and entered into force on 23 March 1976, ratified by the Italian State with law 881/77, of 25 October 1977;

Convention 169 of the International Labor Organization (ILO) of 27 June 1989 on the rights of indigenous and tribal peoples, in force since 5 September 1991 (Article 3, in particular, establishes that indigenous peoples have the right to fully enjoy human rights and fundamental freedoms without discrimination and that the provisions of the Convention must be applied without distinction to men and women of indigenous origin);

As well as, having acknowledged the adhesion of the Veneto State to the Organization of the World Ethics of Tourism, on 2020 December 20, with the solemn adoption of its principles;

art.1- Tourism as an instrument of understanding and mutual respect between peoples and societies:

Understanding and promoting the ethical values common to humanity, in a spirit of tolerance and respect for the diversity of religious, philosophical and moral beliefs, represent the foundation and consequence of responsible tourism; the actors of the tourism sector and the tourists themselves will respect the traditions and social and cultural practices of all peoples, including those of minorities and indigenous peoples, and will recognize their value;

- Tourist activities will be conducted in harmony with the specificities and traditions of the regions and the host country and in compliance with their laws, as well as their customs and traditions;
- Host communities on the one hand, and local professionals on the other, will learn to know and respect tourists and to find out about their lifestyles, tastes and expectations; the education and training given to professionals will contribute to a hospitable welcome;
- The public authorities will ensure the protection of tourists and visitors, as well as that of their property; they will pay special attention to the safety of foreign tourists, by virtue of their possible particular vulnerability; they will also facilitate the use of means of information, prevention, protection, insurance and assistance appropriate to their needs; in accordance with the respective national laws, attacks, assaults, kidnappings and threats against tourists or other persons working in the tourism industry will be severely punished and repressed, as well as the voluntary destruction of tourist facilities or elements; cultural or natural heritage ...

DECREES

the establishment, in the native Veneto territories, of cultural centers of national and international tourism, with licensing to private individuals, in compliance with the definition by UNESCO of the concept of culture:

"Culture in a broad sense can be considered as the set of unique spiritual, material, intellectual and emotional aspects that distinguish a society or a social group. It includes not only art and literature, but also ways of life, the fundamental rights of human beings, systems of values, traditions and beliefs. "

2013 December 23 - The Venetian language is recognized with the ISO 639-3 "vec" identification by UNESCO and classified among the living languages in the Ethnologue catalog and recognized by the Council of Europe in 1981.

Government premises and licensed premises are subject to and protection of jurisdictional immunity from international law of self-determination, (according to Article 10 of the Italian Constitution, Italian Law 881) Decree Law 1, Article 2 of 2019.12.19 of the Council of Ministers, Law 12 of the Veneto Parliament. Responsible offenders will be punished under international law.
