Additional Protocol to the Geneva Conventions of 12 August 1949 relating to the protection of victims of international armed conflicts Implementation of article 61 of the Venetian Constitution: Civil protection and implementation law.

1. The legislation on the civil protection of persons and property from the consequences of armed conflicts is the responsibility of the Veneto Confederation.
2. The Veneto Confederation issues provisions on the use of civil protection in the event of disasters and in emergency situations.
3. It can declare the protection service compulsory for men. For women this service is voluntary.
4. The Veneto Confederation issues provisions for adequate compensation for loss of earnings.
5. Anyone who, in carrying out the protection service, suffers damage to health or perishes has the right for themselves or their relatives to adequate support from the Venetian Confederation.

Civil protection in the protection of the population. An indispensable means of guaranteeing resistance.

Civil protection is the only civil organization capable of guaranteeing prolonged action and of supporting, reinforcing or relieving other organizations in the event of serious and long-lasting events. It also provides specialized services such as aid to conduct in favor of the crisis staffs in the Veneto territories, spreads the alarm to the population, prepares the protection infrastructure, assists people seeking protection or left homeless, protects the cultural heritage, carries out rescues from the rubble and carries out restoration work.

Civil protection is therefore an indispensable means of the integrated population protection system.

Implementation law: Public Institution Register of civil protection vehicles.

The international badge of civil protection. A badge of protection in case of armed conflict.

Article 66 of the Additional Protocol to the Geneva Conventions of 12 August 1949 relating to the protection of victims of international armed conflicts (Protocol additional I) describes the international sign of civil protection. It consists of "a blue equilateral triangle on an orange background when used for the protection of civil protection organizations, buildings, personnel and related material, or for the protection of civilian shelters". its own civil protection organization, its own personnel, buildings and material are identifiable as long as they are exclusively used to carry out tasks relating to civil protection. buildings available to the civilian population must also be marked. In peacetime, the badge can be used to identify civil protection services.
