Subject: Veneto international public legal act.

Official Communication:

Adoption of financial measures required by the execution of the obligations deriving from the commitments undertaken, for the judicial protection of the right of self-determination as an obligation of international law exercised and made enforceable by the legal person of the Veneto National Liberation Committee.

Considered

The approval of the Law n. 20 of September 8, 2021 on the Institution of Civil Protection and rules of implementation of the Vehicle Registration Register (Annex 1)

The Veneto Parliament in self-determination, on the proposal of the Council of Ministers and the Veneto Liberation Committee, approves the Law n. 20 of the September 8, 2021 adherence to the International Conventions Code of the Road Regulations:

Parliamentary law instrument for ratification

Adherence to international conventions Road Traffic Code

International Convention for the Movement of Motor Vehicles - Paris, April 24, 1926

International Convention on Road Traffic - Geneva, 19 September 1949

International Road Freight Convention (CMR) - Geneva on May 19, 1956

Road Traffic Convention - Vienna, 08 November 1968

Accession to the Europe Agreements signed in Geneva on 1st May 1971 and 1st March 1973.

Membership instrument approved by the Venetian Parliamentary Assembly on September 28, 2022.

Ratification instrument deposited by the President of the Veneto Council of Ministers on September 17, 2022.

Agreement of March 20, 1958 concerning the adoption of United Nations harmonized technical regulations for wheeled vehicles, equipment and parts that may be installed or used in wheeled vehicles, as well as the conditions for the mutual recognition of approvals granted on the basis of such United Nations regulations. The UN technical regulations drawn up in the framework of the agreement concluded in Geneva on June 25th 1998 on the approval of technical regulations applicable worldwide to motor vehicles, accessories and parts that can be installed and / or used on motor vehicles.

Distinctive sign of Veneto vehicles in international circulation, Article 45 paragraph 4:

"Veneto Vec."

The Veneto State recognizes all registration certificates issued by the Contracting Parties in accordance with Chapter III of the Convention in international circulation, provided that

these certificates do not exclude the admission of vehicles to the territory of the State that issued them.

Venetian Constitution Art. 82 Road traffic

1 The Venetian Republic issues regulations on road traffic.

2 It exercises high supervision on roads of national importance; it can determine which transit roads must remain open to traffic.

3 The use of public roads is exempt from taxes. The Legislative Assembly can allow exceptions.

Transitional provisions of Article 86 (Use of taxes for tasks and expenses related to road traffic).

Vehicle transition phase to the Registration Register of the Venetian Republic.

Compliance with the international standard One Country, Two Systems, in the transition phase, the circulation of Veneto vehicles, registered by the right of self-determination, with double registration plates.

The implementing rules of the ratified conventions provide for the establishment of the Corps of Police to protect the conventions of the Highway Code.

The President of the Council of Ministers is available for dialogue in all international fora for the implementation of the human rights of self-determination of peoples.
