### **Official Communication: absolute lack of jurisdiction of the Italian State.**

Adoption of financial measures required by the execution of the obligations deriving from the commitments undertaken, for the judicial protection of the right of self-determination as an obligation of International Law exercised and made enforceable by the legal person of the Veneto National Liberation Committee of Europe - C.L.N.V.

The implementation of the right of self-determination has established the executive power, the legislative power and the judicial power of the Veneto State, therefore the Italian State is in absolute lack of jurisdiction, as per the internal law of the Italian State of 25 October 1977, no. 881.

For the judicial protection of the right of self-determination, the executive of the Venetian government, in an official capacity, informs the executive of the government of the Italian State on the application of the sentence T-512/12 of the European Court of Justice in the application of the New York Pacts the enforceability of rights Art. 1, paragraphs 1,2,3, Art. 2 paragraphs 1,2,3 and of paragraph 3 letters a, b, c, and Art. 3, and to the application of the internal law of the Italian State of 25 October 1977, no. 881, (Ratification and execution of the international pact relating to economic, social and cultural rights, as well as the international pact relating to civil and political rights, with optional protocol, adopted and opened for signature in New York on 16 and 19 December 1966 respectively) .

In the exercise of the judiciary's admissibility in the absolute lack of jurisdiction against self-determined, the court costs are not attributable because they claim the right to self-determination and because they are part of a foreign State.

As a legal basis, the reference to sentence T-512/12 and by legal definition a State has been in the relationship with other States, especially the relationship of the Veneto State with other States and with international organizations.

We make you aware that the international law of self-determination of peoples is an erga omnes obligation of human rights.

Any expense in lack of jurisdiction must be attributed to the right of self-determination.

The legal basis attached to this official government communication reminds the Italian State to respect international law and EU law, more precisely for international responsibility for the set of obligations, rights and duties incumbent on the Italian State committing the violation of the inalienable rights of the Draft Articles on State Responsibility of the International Law Commission.

The economic collectability that is attributed to the self-determined is an aggravating circumstance of the person and therefore a genocide of the Veneto People, as they are deprived of their natural, economic, political, social and cultural resources.

The institutional bodies of the Veneto State are available to negotiate a bilateral diplomatic agreement with the Minister for Foreign Affairs and International Cooperation, Leandro Nadin.
