Law Decree: Due implementation of the Law of 25 October 1977, n. 881

Ratification and execution of the International Covenant on Economic, Social and Cultural Rights, as well as the International Covenant on Civil and Political Rights, with optional protocol, adopted and opened for signature in New York on December 16 and 19, respectively 1966.

The self-determined Veneto People of the Veneto National Liberation Committee has freely decide their own political status and to freely pursue their own economical, social and cultural development with the institution of the National Venetian Authority, of Power Government Executive of the Council of Ministers, of the Legislative Power of the Venetian Parliament, of the Attorney General for the protection of the State and of the National Bank of Self-determination of the Veneto people.

The Government of the Veneto People, to achieve the enforceable ends of the Rights of Self-determination of peoples, approves the following provisions by decree:

the self-determined persons of the C.L.N.V. and by law of the Venetian Parliament, can have freely of his wealth by withholding income taxes for the purposes of the right to self-determination.

The States Parties to the present Covenant shall promote the implementation of the Right to Self-determination of peoples and respect this Right, in accordance with the provisions of the Charter of the United Nations. Each of the States Parties to the present Covenant undertakes to respect and guarantee to all individuals who are in its territory and are subject to it to its jurisdiction the Rights recognized in the present Agreement, without distinction of any kind, either it based on race, colour, sex, language, religion, political opinion or any other opinion, national or social origin, economic status, birth or



any other condition. The Italian State has undertaken to comply with this Agreement with the Law N.881 of 1977.
