Object

Jurisdictional protection of the private property of self-determined subjects, as per international law for environmental eco-sustainability of the Land Registry of the Veneto National Liberation Committee, of the Veneto State.

Directive 2018/844/EU EPBD (energy efficiency of buildings), has no juridical and legal application for the properties of the Veneto People, as it has not been agreed with the democratic institutions of the Council of Ministers and the Veneto Parliament.

Any infringement of the private property right of Directive 2018/844 / EU EPBD (energy efficiency of buildings), will be charged to the cost of compensation to members of the European Commission and the Council of Europe, for violation of inalienable and mandatory obligations erga omnes of international law, political, economic, social, cultural rights of self-determination and natural resources. Directive 2018/844/EU EPBD (energy efficiency of buildings), has no juridical and legal application on the private properties of the self-determined Veneto People, of the Cadastral Register of the Veneto State.

The self-determined Veneto People of the Veneto National Liberation Committee, freely decided their political status to freely pursue their economic, social and cultural development and to dispose of their natural resources. With the Institution of the Venetian National Authority (A.N.V.), of the Executive Power of Government of the Council of Ministers, of the Legislative Power of the Veneto Parliament, of the General Prosecutor's Office for the protection of the Veneto State and of the Venetian National self-determination Bank (Banca Nazionale Veneta - B.N.V.) of the Veneto People.

We claim OUR inalienable right of self-determination; the absolute prohibition on the use of our inalienable and imperative political, economic, social, cultural and natural resource rights is intimated, declared, notified and signed, both by the Italian State and by an International Organization and in a special way, by European Union "sui generis" organization, to protect privacy and our personal data.

Right to privacy

Art. 12 of the DIDU (International Declaration of Human Rights);

Article 17 of the International Covenant on Civil and Political Rights (New York Covenant):

No one shall be subjected to arbitrary interference with his privacy, family, home or correspondence, nor to attacks on his honor and reputation. Everyone has the right to the protection of the law against such interference or harm.

Any use of European standards and directives concerning the Veneto People, in order to be effective and of legal value, must be agreed from time to time with the Government Executive, by the President of the Council of Ministers, Mr. Moravio Pianegonda.

For any violation of the Right of Self-determination, with coercive methods, by bodies acting on behalf of the Organization "sui generis" European Union, an official complaint will be presented to the International Courts of Justice and Human Rights, to compensate the violation of human rights .

The Court of reference of the Veneto Council of Ministers is the International Court of Justice (ICJ) based in The Hague.
