Subject: Official Communication Law on Natural Resource Production Activities.

(One country, two systems). Legally binding instrument of mandatory rules (*ius cogens*) of general international law. From the obligations, rights and duties deriving from the rules of international law.

Law No. 36 approved:

Without prejudice to the regulation governing the conduct of commercial activities in public areas, pursuant to Regional Law 25 June 1999, no. 12 "Rules for the regulation of commerce on public areas in implementation of the legislative decree 31 March 1998, n. 114", resolution of the Municipal Councils, of the Regional Councils.

This Parliamentary law authorizes the exercise of self-determination;

For self-determined operators of the Veneto National Liberation Committee of Europe, of commerce on public areas for retail and wholesale sales of goods and for the administration of food and beverages carried out on public areas.

The issue of the parking permit, in the part of the public area, is given in concession to the self-determined operator of the C.L.N.V., subject to authorization for the exercise of the commercial activity, registered in the appropriate register of itinerant productive activities of the Ministry of economic development, of industry, commerce, crafts, agriculture, technological innovation, digital transition and Made in Veneto, of the Veneto National Liberation Committee of Europe.

The public area space in concession to the self-determined operator of the C.L.N.V. it's free.

All PDO, PGI and STG producers have the right to be registered in the appropriate register of self-determined companies of the C.L.N.V., therefore they are recipients of this law.

The executive government of the Italian State is informed of the existence of this parliamentary law, so that it is operational in every Municipality of the territories of the LEGISLATIVE DECREE, 13 December 2010, n. 212 in compliance with the LAW of 25 October 1977, n. 881.

The self-determined companies of the C.L.N.V. fully enjoy the rights of self-determination for tax purposes. No taxation of the Italian State is applied.

To protect the human right of self-determination in the municipal spaces used on market days, the presence of representatives of the Environmental Police is guaranteed, equipped with an identification card.

To protect the mandatory rules of international law:

DRAFT ARTICLES ON STATE ACCOUNTABILITY OF THE COMMISSION ON INTERNATIONAL LAW (2001). SERIOUS VIOLATIONS OF OBLIGATIONS ARISING FROM IMPERATIVE RULES OF GENERAL INTERNATIONAL LAW.

Article 40. Application of this chapter

1. This chapter applies to international liability arising from a serious breach by the State of an obligation arising under a peremptory norm of general international law.
2. A breach of such an obligation is serious if it involves a clear and systematic breach of the duty to fulfill the obligation by the responsible State.

Article 41. Particular consequences of a serious breach of an obligation under this chapter

1. States shall cooperate to put an end by lawful means to any serious violation under article 40.
2. No State shall recognize as legitimate a situation created through a serious violation under article 40, nor shall render aid or assistance in maintaining such a situation.
3. This article is without prejudice to the other consequences provided for in this part and to the further consequences which a violation to which this chapter applies may have under international law.

The President of the Council of Ministers of the Veneto State presents the invitation, makes himself available and hopes for a meeting with the President of the Council of Ministers of the Italian State and with the local authorities for the purpose of effective cooperation, with the aim of making rights humans mentioned above, payable.

This international public legal act and legitimized by parliamentary law, enters into force and authorizes in every Municipality of the Veneto State, from the thirtieth day of its
