PROEM INTERNATIONAL ACTS AND TREATIES

The mission of the Veneto National Liberation Committee of Europe is to promote universal and effective respect for the fundamental rights of peoples, determining whether these rights are violated, examining the causes of such violations and denouncing their perpetrators to world public opinion.

The Veneto National Liberation Committee applies the international principles of JUS COGENS as an expression of universal legal awareness, in particular of the Nuremberg principles; adopts the Algiers Declaration on the Fundamental Rights of Peoples and applies the fundamental legal instruments of the United Nations, in particular the Universal Declaration and the international pacts on human rights, the declaration on friendly relations between States, the resolutions of the General Assembly on Decolonization and the new international economic order, the Charter of economic rights and duties of States as well as the Convention on the Prevention and Suppression of the Crime of Genocide.

The Veneto National Liberation Committee also applies any other international, universal or regional legal instrument aimed at developing, updating or broadening the meaning and contents of the texts that refer to the rights of peoples.

Self-determination is the law of the Italian state in compliance with the United Nations Charter and human rights with adherence to the United Nations, the O.C.S.E. and to all international treaties of law and to the exercise of self-determination.

BRIEF NOTES ON THE VENETO D'EUROPA NATIONAL LIBERATION COMMITTEE

The Veneto Liberation Committee (C.L.N.V.) of the peoples of Europe, was born with a deed of foundation on 25 December 2014 in Vicenza by the hand of two founders and 23 other subscribers and subsequently with documentation delivered by hand to the U.N. in Geneva on 25 July 2016.

The C.L.N.V. pursues, on the basis of international laws relating to the Decolonization process, in compliance with the provisions of art. 96.3 of the 1st Additional Protocol to the Geneva Conventions of 12 August 1949, adopted in Geneva on 8 June 1977, ratified by Italy with law no. 762 (in the Ordinary Supplement to the Official Gazette no. 303, of December 27, 1985).

The C.L.N.V. is a subject of international law that claims the pacts, treaties and laws on the self-determination of peoples, through International Law, New York Pact 881/66, ratified in 1977 by the Italian State with law 881/77. The C.L.N.V. issued the National Council of the Veneto People - A.N.V. (Venetian National Authority), which represents the provisional government and a Constituent Assembly.

The purpose of the C.L.N.V. is primarily to ensure that the Veneto people return to being independent and sovereign over their territories from Bergamo to Gorizia such as the Istrian and Dalmatian territories, as it was in the past for 1,100 years consecutively with the Serenissima Republic of Venice or the Republic of Venice.

These centuries of history, culture and traditions preserved in common, the Venetian language, recognized with the ISO 639-9 "VEC" identification by Unesco and classified among the living languages in the Ethnologue catalog, as well as recognized by the Council of Europe in 1981, they ensure that the People of Veneto are still fully existing and respected for being peaceful, ingenious, determined, neutral since 1500, autonomous and enterprising.

The Veneto people have been settled in these territories for 3,500 years (archaeological and historical finds visible in the museum of Este - Padua).

There are various primates of this people; from having been the first to abolish slavery as early as the 16th century, to the first woman who graduated in the world, Elisa Cornaro, in 1678 at the University of Padua, to have had equal justice for all with laws and regulations based also on respect of nature and universal laws. Timeless values and principles ensured that the people were always the "heart" of the Republic; the last citizen was never the last and everyone had equal opportunities.

After the plebiscite fraud of 21-22 October 1866 and from that moment on, having been coercively annexed to the Kingdom of Italy (with military presence and local prefects already from 18 July 1866, in contravention of the agreements of the Treaty of Vienna) the Veneto Affair began, with colonial exploitation of the population that originated the Venetian Diaspora and which still lives today, after more than 150 years, with unsustainable taxation of 65-70% or more. The imposition of the Italian

language, the territorial division into different regions and the massive military presence, have meant that a large part of the Venetians lost the memory of their origins, their history and therefore their true identity, of which today it is still may notice the omission on school books.

In these years, since 2016, the C.L.N.V. has seen an operation on the territory with declarations, communications, actions and claims to the various institutional bodies of the territory to have their presence observed, both physical and institutional, also by virtue of Legislative Decree 212/2010, which repeals the Royal Decree of annexation of the Venetian Territories to the then Kingdom of Italian 1866, as well as promoting and disseminating law 881/66 "New York Pact", ratified by the Italian State in 1977, also in institutional offices.

Legal terms

The Latin term **ius cogens** ("mandatory law") indicates, in international law, the customary rules which are placed to protect values considered fundamental and which cannot be derogated from in any way. The *ius cogens* is perceived by the members of the so-called international community (states in particular) as an absolutely mandatory right.

The Latin phrase **pacta sunt servanda** (pacts must be observed) expresses a fundamental principle of civil law and international law.

The Latin term **erga omnes** means "towards everyone". In legal language, it is customary to say that a rule applicable to entire categories of people has effect *erga omnes*.
