We are sending this to communicate that all deeds, treaties and communications issued from 1 October 2023 and not signed by the President and founder of C.L.N.V. - CLNVeneto (Venetian National Liberation Committee), Amedeo Casasola or by the founder of C.L.N.V. - CLNVeneto and current President of the Venetian National Authority - A.N.V., Moravio Pianegonda, are not to be taken into consideration as acts legitimized by the international legal entity Veneto National Liberation Committee (C.L.N.V. - CLNVeneto.net).

Therefore, with dismay, we distance ourselves from the fraudulent use of C.L.N.V. letter-heads which contain untruthful messages, not endorsed and not granted by the A.N.V. of the C.L.N.V, by people from the board of directors, who were dismissed for serious disciplinary and defamatory reasons.
