Subject: C.L.N.V. Declaration of Dissent to the Amendments to the International Health Regulations - IHR

Dear Director General,

The Veneto National Liberation Committee (C.L.N.V.), representing self-determined citizens who are aware of their inviolable rights, wishes to express its formal and reasoned dissent regarding the proposed amendments to the International Health Regulations (IHR), scheduled for approval by 19 July 2025.

These amendments, in their current form, profoundly undermine the fundamental principles of individual freedom, national health sovereignty and self-determination of the person, as recognized and protected by numerous international legal instruments.

Key legal references In particular, we refer to the provisions of:

- The Oviedo Convention (Council of Europe Convention on Human Rights and Biomedicine, 1997), which in Article 5 establishes the principle of free and informed consent of every person with regard to any health intervention;

- Universal Declaration of Human Rights (1948), in particular Article 3 ('Everyone has the right to life, liberty and security of person') and Article 18 (freedom of thought and conscience);

- Charter of Fundamental Rights of the European Union (2000), which in Article 3 protects the right to personal integrity, including respect for informed consent in the medical field;

- International Covenant on Civil and Political Rights (UN, 1966), which protects individuals from treatment imposed against their will, except under strictly defined and justified conditions.

Reasons for dissent

The proposed amendments to the IHR seem aimed at conferring binding supranational authority on the WHO in decisive areas such as:

- The declaration of health emergencies;
- The centralized definition of diagnoses and permitted treatments;
- The imposition of health interventions, even in the experimental phase;

- The control of scientific and media information, limiting freedom of expression and research.

Such concentrated powers risk suspending fundamental civil rights, including the right to scientific dissent and the autonomous assessment of risks and benefits by each individual or community.

In light of the above, the C.L.N.V.:

- formally rejects the amendments to the RSI, as they are incompatible with the fundamental rights recognized by international law;

- reaffirms its commitment to continue exercising its right of jurisdiction in full Independence, in accordance with the principles of self-determination of peoples;

- will continue to protect the freedom and integrity of individuals of Venetian nationality in self-determination, residing in the territories historically belonging to the Venetian Nation, defending them from any form of health imposition or coercion foreign to their free and informed will;

- reaffirms the right of citizens to refuse imposed health treatments and to maintain control over decisions concerning their own bodies and health;

and

calls on the WHO to respect the principle of subsidiarity and scientific pluralism, avoiding any form of authoritarian monopoly in health matters.

We remain open to open and constructive dialogue based on law and mutual respect between peoples, institutions and individuals.
