### Statement of condemnation

To the International Community,

To the Governments and competent Institutions,

To world public opinion,

The **Veneto National Liberation Committee - C.L.N.V.**, through its **President Amedeo Casasola** and the **President of the Veneto National Authority - A.N.V., Moravio Pianegonda**, expresses its firm and unequivocal condemnation of the actions of the State of Israel in the Gaza Strip, which constitute serious violations of international humanitarian law and which we consider to be a crime against humanity and an act of genocide against the Palestinian people.

For months we have witnessed indiscriminate bombing, total blockades of essential goods, destruction of civilian infrastructure, hospitals and schools, and the systematic killing of thousands of people, including a very high number of children. These acts, perpetrated with impunity, represent a deliberate policy of annihilation of the civilian population of Gaza.

We condemn with equal firmness the moral and political responsibility of the **international community**, which through its inaction, complicity or direct support perpetuates injustice. The failure to recognise the State of Palestine and the absence of concrete measures to stop the massacres not only legitimise the oppressor, but betray the founding principles of the United Nations Charter and the Universal Declaration of Human Rights.

### We demand

1. An **immediate end** to Israeli military operations in the Gaza Strip.
2. An **end to the blockade** imposed on the population and immediate and safe access to humanitarian aid.
3. **Official and universal recognition of the State of Palestine** within the 1967 borders, with East Jerusalem as its capital.

4. **Immediate activation of international jurisdiction** (ICC and other bodies) to investigate and prosecute those responsible for the crimes committed.

The Veneto National Liberation Committee - C.L.N.V. reaffirms its commitment to non-violent resistance and to the construction of a just and lasting peace, based on respect for the inalienable rights of all peoples.

However, peace cannot exist without justice: silence and inaction are also forms of violence.
